And whereas the policy further states that each application will be considered on its own merits. It is as well, Council's intention to provide public access along shoreline as they presently exist (10-foot strips previously retained).

Now therefore be it resolved that the request from Simon Kasprzak of Adam Kasprzak Surveying Ltd on behalf of Mr. Brian Kenney to purchase a portion of the unopened shoreline road allowance on Corry Lake adjacent to his property located at 1373 Sand Rd be declined.
